Sri Tapom Chahal using electricity without change of meter ownership as per norms of WBSSEDCL and also no information given about expiry of Lt Manoj Chahal.

During infection we recorded the meter data such as  
1) Com. ID - 242053692, 2) Meter No - 5M007066 3) Reading - 10763  
and also in coming ckt. verifications.

After searching on all the load connected at the time of deep infection it was found that meter was tampered by a thin wire entering into the meter to damage the internal circuit to stop counting mechanism through a tiny hole.

So, the meter was stop for reading advance. As the meter stop by force by the users, and enjoying electricity dishonestly by means of meter tampered.

Due to the act or status above the person has committed an offence under section 135(1)(b) of the electricity act 2003 (Amendment act 2004).

After disconnection the wire from the pole, the tampered meter was removed and sealed & seized properly by means of cloth (white) and paper at site in presence of Const Smt Sika Chahal wife of Tapom Chahal and Sri Manoj Chahal uncle of Tapom Chahal.

Properly tagged with signature of above persons. We left the premises of Mr. Tapom Chahal at about 4.30 PM & lodged necessary complaint as per law to Raghunath P.S.

So, you are requested to take necessary action of the complain and treat it as also PIR.
