Sir,

This is to inform you that during routine checking of Conveyor 32B on 08.09.2017 at around 7:00 a.m. by the departmental personnel of CHP (Oprn.) Department, it was observed that 20 nos. of Carrier Rollers are missing from the tail of the Conveyor 32B. Out of these 20 missing rollers 07 no. rollers were found in the stairway of T. P.-31. Out of these 7 recovered rollers, 3 rollers were found packed in a cement bag and the remaining 4 were found strewn along the stair case.

Approximate cost of the missing 13 no. rollers comes to Rs.13,507/- (Rupees thirteen thousand five hundred and seven).

Some photographs are attached to facilitate the investigating process.

You are requested to kindly look into the matter for further necessary course in this regard.
