I SI Mukul Karmakar O/C Adra Police Station do hereby lodge suo-moto complaint against the above noted arrested accused persons and accused Suraj Chouhan and 100/150 others to the effect that on 23.10.17 Barakali Puja Committee of Palashkola, Adra organized an immersion procession with the idol of goddess Kali with 11 (eleven) pieces of sound boxes without sound limiter, 06 pieces of mike fitted on the vehicle No. WB 55 7699. ASI Giridhari Roy along with C/447 Kshirod Singn Sardar C/5 Pabitra Murmu NVF/800 Jagannath Mahato NVF/163 Laxmikanta Mahato NVF/587 Chiranjit Mahato NVF/1087 Shankar Gorai LC/398 Chaitali Mukherjee LC/83 Monika Mahato were entrusted to cover the said procession vide Adra PS Spl. CC No. 616 Dt 23.10.17 & GDE No. 860 Dt. 23.10.17. At 19:05 hrs. ASI Giridhari Roy informed me over telephone that some members of the procession are disturbing his lawful directions & they are in a mood to create law & order problem. Accordingly myself along with JC/331 Swapan Mahato JC/215 Bubun Sen JC/322 Ramdhan Dey JC/288 Manaranjan Kar JC/1008 Bablu Gorai JC/1183 Mithun Das JC/1247 Badyanath Soren JC/283 Tanmoy Saha JC/1042 Tapas Malla JC/245 Birendra Nath Shit (Assault Group) & CVF- Atibul Ansary CVF-Amal Bouri CVF-Manoj Bouri CVF- Asesh Tewary left PS to assist ASI Giridhari Roy. Vide Adra PS Spl. CC No. 624 Dt. 23.10.17 & GDE No. 869 Dt 23.10.17 I met with the said procession at Young Market at 19:35 hrs.

In this context I would like to note here that a meeting was conveyed at the PS compound on 17.10.17 with all the community puja organizers. Barakali Puja Committee also attend the said meeting. In the said meeting all puja committees were sensitized about the order of Hon'ble High Court and other legal formalities specially on playing of microphone.

At 22:00 hrs. they crossed New Level Crossing on Adra-Purulia Rail Line and they approaching towards Palashkola. As the scheduled time for playing Microphone as per guidance of Hon'ble High Court was over I asked the president of said puja committee namely Santosh Dubey & the secretary of the said puja committee who were in full command of the said procession, not to play sound box in loud volume.

At 22:30 hrs. the procession reached in front of Adra PS main gate I again asked them not to play the sound box any more. But they were not in mood to obey my lawful directions. More over they picked up quarrel with us. I and accompanying officer & force tried our best to pacify them & to make them understood the directions of Hon'ble High Court. As the above noted arrested accused persons along with 100/150 others caused and unlawful assembly with Lathi, Stone etc. restrain and assaulted public servant while discharging Govt. duty causing their serious injury, mischief of Police vehicle and disobeyed the Hon'ble High Court and damaged Govt property. They are liable to procession U/S 147/148/149/186/353/326/307/188 IPC & 3/4 PDPP Act.

On returned to PS after producing the arrested accused persons & selzed properties I registered this case suo-moto. SI Parikshit Mahato will investigate the case.
