In producing here with one arrested accd. namely Bhairab Bouri (50 Yrs.) S/O Nepal Bouri of Vill- Raguri (Bouri Para) PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 17 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs.-65/-
- 3) Eight pieces of plastic glass.

I ASI Habibul Rahaman Mondal of Adra P.S. do here by lodged a complaint against accd. Bhairab Bouri (50 Yrs.) S/O Nepal Bouri of Vill- Raguri (Bouri Para) PS- Adra Dist- Purulia to the effect that on 15.10.17 at about 17:45 hrs in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one Bhairab Bouri (50 Yrs.) S/O Nepal Bouri of Vill- Raguri (Bouri Para) PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/411 Pinku Saha & JC/340 Aswini Mondal rushed to the spot for raid by Govt. vehicle. At about 18:35 hrs. myself along with force reached at Jyoti More, Adra and hold raid in the Jhupri at Vill- Raguri (Bouri Para) in front the hose of Bhairab Bouri (50 Yrs.) S/O Nepal Bouri found that said Bhairab Bouri liquor at his own Jhupri and seeing the Police party some person fled away and said Bhairab Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Bhairab Bouri (50 Yrs.) S/O Nepal Bouri of Vill- Raguri (Bouri Para) PS- Adra Dist- Purulia and arrange for its investigation.
