Respected Sir,

In producing herewith one arrested accd. S. Srinibas Rao @ Srinu (35 yrs.) S/O S.P Balasubramaniyam of Jhupri near Mama More, P.S- Adra, Dist.- Purulia along with seized articles 1) 18 bottles (in sealed condition) of DIL KHUSH 80 up country spirit, 600ml each bottle and Rs 30 of each bottle, (2) 06 (six) pieces of plastic glasses, and (3) Sale proceed of Rs- 87/= before O/C Adra PS, Dist.- Purulia. I beg to report that on 29/10/17 in course of mobile duty vide Adra P.S GDE No. 1112 dtd. 29/10/17, myself along with force got reliable source information that one person is illegally stocking country spirit and selling the same with a hiked price for his personal gains at his Tea Stall near Mama More, P.S- Adra, Dist.- Purulia. Then I informed O/C Adra P.S and as per his direction I SI Supratik Mondal along with JC/340 Ashwini Mondal and JC/342 Kashinath Chakraborty been to the spot for raid by govt. vehicle. At about 19.05 hrs. I along with force reached at Mama More, Adra and held raid in the Tea Stall at Mama More of S.Srinibas Rao @ Srinu (35 yrs.) S/O S.P Balasubramaniyam of Jhupri near Mama More, P.S- Adra, Dist.- Purulia and found that he was selling country spirit at his own tea stall and seeing the police party some persons fled away from the spot and the said S. Srinibas Rao @ Srinu tried to conceal himself but I was able to apprehend him and also detained him. I asked him to produce any valid license or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing/selling the same. So, I seized 1) 18 bottles (in sealed condition) of DIL KHUSH 80 up country spirit, 600ml each bottle and Rs 30 of each bottle, (2) 06 (six) pieces of plastic glasses, and (3) Sale proceed of Rs- 87/= under proper seizure list duly signed by the accd. person and available witnesses and arrested him u/s 46 A(C) of the Bengal Excise Act against arrested accd. namely S. Srinibas Rao @ Srinu (35 yrs.) S/O S.P Balasubramaniyam of Jhupri near Mama More, P.S- Adra, Dist.- Purulia after informing them the ground of arrest and I prepared arrest memo after maintaining all arresting rule I brought them to P.S. with seizure list and above noted seized articles.

Therefore I pray before you that kindly start a case under proper section of law against arrested accused S. Srinibas Rao @ Srinu (35 yrs.) S/O S.P Balasubramaniyam of Jhupri near Mama More, P.S- Adra, Dist.- Purulia and arrange for its investigation.
