He is using electricity by hooking method from nearest LT network with the help of PVC wire which indicates use of electricity dishonestly. He is using two nos bulbs and one fan with hooking device.

As the theft of electricity was detected during inspection by hooking method, we disconnected the unauthorised electric line and seized the seizure article in proper seizure list as token basis. The total people refused to put signature in the seizure list. After completion the inspection we left the spot at about 2 P.M.

The accused person has committed an offence u/s 135 (1)(a) of the electricity act 2003 and subsequently amendment act 2007. You are requested to take cognizance of this complaint and treat it as F.I.R. only.
