Sir,

In producing herewith one accused person namely Deepak Sing (21 yrs) S/O- Shyam Sing of Vill.- Parkidih, P.S.- Balarampur, Dist.-Purulia along with 32 (thirty two) seized Mobiles as per seizure list, I SI Asoke Kr. sen of Balarampur PS lodged a complainant against the above noted accused person to the effect that on 03.10.17 at 09.05 hrs received a credible source information from my reliable source that one Deepak Sing S/O- Shyam Sing of Vill.- Parkidih, P.S.- Balarampur, Dist.-Purulia & others engaged in the business of stolen Mobile at present accumulated some stolen Mobiles at his house of village Parkidih PS-Balarampur Dist-Purulia. This refers to Balarampur PS GDE No-101 Dtd-03.10.17. To work out the source information I SI. Asoke Kr. Sen along with 1) ASI Santosh Roy 2) C/423 Ranjan Ghatak, 3) JC/377 Arjun Yadav 4) JC/378 Palash Mukherjee 5) JC/1175 Ratnakamal Saha had been to Parkidih village & held raid in the house of accused Deepak Sing. On searching we found 32 (thirty two) Mobiles and asked him to produce the relevant documents in respect of following Mobiles but he failed to produce any valid documents in respect of the following Mobiles and during interrogation he clearly confessed that he along with others habitually deal with the business of stolen Mobile in a clandestine manners from last few years. I seized the following Mobiles from his possession after preparing proper seizure list and duly signed by accused person & accompany Police persons because the local people refused to sign in seizure list.
