Respected Sir,

In producing here with two arrested accused persons namely i) Yudhistir Singh Sardar (33 yrs) S/o-Monohar Singh, ii) Kalipada Singh Sardar (33 yrs) S/o- Lt. Khudiram Singh Sardar both of Vill.- Saiburdi, P.S.- Balarampur, Dist. Purulia along with seized 50 (fifty) sealed country sprit bottles (DIL KHUS) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:25 hrs I received a credible source information that two persons namely i) Yudhistir Singh Sardar (33 yrs) S/o-Monohar Singh, ii) Kalipada Singh Sardar (34 yrs) S/o- Lt. Khudiram Singh Sardar both of Vill.- Saiburdi, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at Saiburdi under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Saiburdi to work out the source information and held raid in the shop of accused persons.

During search with the help of accompany force, we found that the said persons are selling country sprit bottles at their own house. On demand, they failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 30 (thirty) liters country sprit has been seized, total value of the said seized sprit is Rs-1750/= (one thousand seven hundred fifty only) and arrested them after preparing proper arrest memo as they committed offence U/S 46A(C) B.E. Act and supply one copy to them.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused persons namely i) Yudhistir Singh Sardar (33 yrs) S/o-Monohar Singh, ii) Kalipada Singh Sardar (33 yrs) S/o- Lt. Khudiram Singh Sardar both of Vill.- Saiburdi, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
