I do hereby lodge complaint empowered by enabling
the electricity act-2003 subsequently electricity (Amendment) act
2007 to the effect that, Nirmal Ko. Mondal was enjoying
electricity unauthorizedly i.e. bypassing of energy meter i.e.
cutting of incoming service connection cable with another two
piece wire connection which flows to the change over switch
directly without any meter consumption and due to this
reason he has committed theft of electricity u/s 135 (1b)
of the electricity (Amendment Act-2007).

Entered the premises of Nirmal Kr. Mondal, s/o - Lt. Sudhir Mondal Vill - Kurra P.S - Bunderan Dist - Purulia having Con. Id: 242100284 Meter No: R0044743 and inspected his premises. During the inspection theft of electricity was detected. Another service connection in the name of Swapna Mondal was existing there but those two service connections were not connected with Metal clad change over switch and due to this reason both the service connections were disconnected from pole site. The details of passing arrangement was damage installation of incoming wire which electricity directly flows to his house without energy registration in WBSEDCL energy meter.

From the above by passing system he uses the following electrical equipments: 1) Electric water pump - 01 no. 2) Electric bulb - 04 nos. 3) Color TV - 01 no. 4) Freeze - 01 no 5) Electric Fan - 05 nos. 6) Xerox Machine - 01 no. 7) Computer - 01 no.

Out of which I seized the following:

- 1) PVC cable 5'ft (Approx) 2 core alongwith bypassing arrangement.
- 2) Meter vide Meter No: R0044743.

Seizure list was prepared at site and accused person signed. The inspection team left the premises at 12.50 PM on 14/10/17. The accused person has committed of an offence u/s 135(1/a) of the electricity act 2003 subsequently Amendment Act 2007.

You are requested to take cognizance of this complaint & treat it as F.T.R and action may be taken as per rule.
