Sub: Prayer for starting a specific case against Swarup Mahato (28 Yrs) S/o- Lalmohan Mahato of Village- Dhadkidih, PS- Barabazar, Dist- Purulia A/P- Village- Hizla, PS- Barabazar, Dist- Purulia.

Sir,

In producing herewith one accused person namely Swarup Mahato (28 Yrs) S/o- Lalmohan Mahato of Village- Dhadkidih, PS- Barabazar, Dist- Purulia A/P- Village- Hizla, PS- Barabazar, Dist- Purulia under arrest and the following seized articles under seizure list enclosed herewith

- 1) Sixteen (16) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.
- 2) Eight (08) sealed plastic bottles (CS) containing 375 ml each and labelled with DILKHUSH.
- 3) One yellow nylon bag.
- 4) One white polythin chat

Sir,

I ASI Gnan Sankar Pati of Barabazar PS do hereby lodge this complaint regarding that today (18.10.2017) at about 18.05 hrs during my special evening mobile duty at Sindri side received source information over telephone that the above noted accused person has been selling ID liquor illegally and clandestinely in front of his residential house at Hizla more of Hizla village right side of Barabazar-Sindri pitch road under Barabazar PS. On receiving the reliable source information I communicated with I/C Barabazar PS over telephone and as per his instruction I along with C/- 292 Tazibul Rahaman, C/- 563 Tapas Mal both of SAP 7<sup>th</sup> Bn. camp at Barabazar PS rushed to the spot to work out the information. On arriving to the spot at 18.25 I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. One bottle 600 ml ID liquor has been kept as sample taken from that seizure which was also duly labelled and also took signature of the accompanying witness on seizer list and label .After this I arrested that accused person namely Swarup Mahato (28 Yrs) S/o- Lalmohan Mahato of Village- Dhadkidih, PS- Barabazar, Dist- Purulia A/P- Village- Hizla, PS- Barabazar, Dist- Purulia after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
