Sub: Complaint against Girijal Murmu (45 Yrs approx), S/O- Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one accd. Person Girijal Murmu (45 Yrs approx), S/O- Lt. Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia with seizure of (1) 20(Twenty) Ltrs. I.D. Liquor in a Jariken, (2) 03 sealed bottles of 80-up DILKHUSH Country Spirit each Bottle contains 600 ml., M.R.P. Rs. 30/- each, (3) 06 sealed bottles of 80-up DILKHUSH Country Spirit each Bottle contains 375 ml., M.R.P. Rs. 19/- each, total value (19*06) = 114/- which was seized under proper seizure list.

I beg to submit that today (16.10.17) in between 15.45 hrs to 16.15 hrs a raid was conducted in the house of Girijal Murmu (45 Yrs approx), S/O- Lt. Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia. On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit and I.D. liquor which were kept in his house. On demand he failed to produced any valid documents in respect of selling of liquor from his house. As such he was arrested at 16.15 hrs u/s 67 B.E.Act and also seized also the articles under proper seizure list in presence of witnesses, u/s 67 A (C) B.E.Act which enclosed here with. Out of seized articles one ltr. I.D. liquor of SL No. 1 taken out and one Bottle each from SL No. 2 and 3, as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The above noted arrested accd. Girijal Murmu (45 Yrs approx), S/O- Lt. Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia Committed offence u/s 46 A (C) B.E. Act. 1909 for unauthorized possession and sale of country spirit and I.D. liqueur from his house at Ukamgarh, P.S. Boro Dist- Purulia.

It may note here that during raid (1) C /887- Manaranjan Dey, (2) C/ 431 Surendranath Dubey accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E.Act. 1909 may kindly be started against Girijal Murmu (45 Yrs approx), S/O- Lt. Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia
