Sir,

In producing here with 01 (one) arrested accused person namely Mahitosh Mahato @ Pintu, 38 years S/O Lt Chandi Charan Mahato of Village- Gokulnagar, PS - Jhalda, Dist- Purulia and brought under seizure the following articles total 32 (thirty two)bottles of ELTUREX cough syrup containing 100 ml in each bottle(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLOIRIDE syrup) batch No-SD17020,Exp date-April-2019. Manufactured in India by Smilex Health Care Pvt. Ltd into one poly bag. I do here by lodged a written complaint to the effect that on 03/10/17 at 19:45 hrs received a telephonic information from my source that 01(one) person i.e. Pintu is selling cough syrup in his shop beside Saldaha River bridge ,huge quantities of drugs with him. After received such type of information myself along with force C/ 676 Swapan Rakshit, C/ 1021 Laxmikanta Bouri, C/ 797 Chandi Charan Rajak who were performing evening mobile duty rushed to Gokulnagar more and keep our vehicle in a dark place. We silently go there at 20:15 hrs and we found one person is on there. We intercepted him. On being searched we found 32 (thirty two)bottles of ELTUREX cough syrup containing 100 ml in each bottle(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLOIRIDE syrup) batch No-SD17020, Exp date-April-2019 Manufactured in India by Smilex Health Care Pvt. Ltd into one poly bag from his shop. On being asked he disclosed his identity as noted above. On demand he failed to produce any valid document/ licence in respect of keeping the said drugs. On close interrogation he disclosed that one Sanjay Karmakar S/O Lt Nirod Karmakar of Vill- Moshina opposite INC party office Jhalda, PS- Jhalda, Dist-Purulia supplied him the said illegal cough syrup with a contact of commission of sale proceed. Accordingly I seized the same under proper seizure list duly signed by the witnesses as well as the apprehended person and myself along with force held raid in the house of Sanjoy Karnakar but no fruit full result achieved.

I therefore pray before you to start a case against the two accused person namely 1) Mahitosh Mahato @ Pintu S/O Lt Chandi Charan Mahato of Village- Gokulnagar, PS – Jhalda, Dist- Purulia (2) Sanjay Karmakar S/O Lt Nirod Karmakar of Vill- Moshina opposite INC party office Jhalda, PS- Jhalda, Dist-Purulia under proper section of Law and arranged for its investigation.
