I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Paban Kumar, S/O- Lt. Shisupal Kumar of village:- Barabendya, P.S-Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 25.10.2017 at about 3.25 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato,Gr1 TSH 2. Shibaram Mahato,HG TSH, entered the premises of Sri Paban Kumar, S/O-Lt.Shisupal Kumar of village- Barabendya, P.S-Joypur, Dist- Purulia and found Sri Paban Kumar was enjoying electricity unauthorizedly drawing power from the nearest L &MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.25 KW. As Sri Paban Kumar S/O- Lt. Shisupal Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato,Gr1 TSH 2. Sri Shibaram Mahato,HG TSH.The inspection team left the premises at 3.50 PM.
