In producing here with one Biren Mahato (70) S/O – Lt Labu Mahato of village Daldali, PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 19 Liters (Approx) of country spirit contained in a plastic container
- 2) 100 grams (Approx) NISHADAL,
- 3) Four pieces of plastic glass &
- 4) Sale proceed of Rs. 110/--

I ASI Indrajit Sarkar of Kashipur P.S. do here by lodged a complaint against accd. namely Biren Mahato (70) S/O – Lt Labu Mahato of village Daldali, PS- Kashipur, Dist- Purulia to the effect that today (15.10.17) at about 18.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Biren Mahato (70) S/O – Lt Labu Mahato of village Daldali, PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Daldali village and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per direction of O/C Kashipur PS myself along with C/118 Dwijapada Mahato and C/59 Manindranath Mahato both of Kashipur PS rushed to the spot for holding raid by Govt vehicle. At about 19.35 hrs myself along with force reached at Daldali village and held raid in the house of Biren Mahato (70) S/O – Lt Labu Mahato of village Daldali, PS- Kashipur, Dist- Purulia and found that Biren Mahato was mixing the country spirit, contained in plastic Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his house at Daldali village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Biren Mahato, and detained him. I asked him about the white powder like substance and accordingly, detained Biren Mahato recognized it as "NISHADAL" (approx. 100 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Biren Mahato (70) S/O – Lt Labu Mahato of village Daldali, PS- Kashipur, Dist- Purulia and arrange for its investigation.
