

In producing here with one Samar Mandal (37) S/O – Ananda Mandal of village Sonaijuri, PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 18 Liters (Approx) of country spirit contained in a plastic container
- 2) 150 grams (Approx) NISHADAL,
- 3) Six pieces of plastic glass &
- 4) Sale proceed of Rs. 135/--

I ASI Jayanta Chakraborty of Kashipur P.S. do here by lodged a complaint against accd. namely Samar Mandal (37) S/O - Ananda Mandal of village Sonaijuri, PS- Kashipur, Dist-Purulia to the effect that today (15.10.17) at about 18.25 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Samar Mandal (37) S/O – Ananda Mandal of village Sonaijuri, PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Sonaijuri village and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per direction of O/C Kashipur PS myself along with JC/977 Tarun Kadam and JC/1187 Samaresh Shit both of Kashipur PS rushed to the spot for holding raid by Govt vehicle. At about 19.15 hrs myself along with force reached at Sonaijuri village and held raid in the house of Samar Mandal (37) S/O - Ananda Mandal of village Sonaijuri, PS- Kashipur, Dist-Purulia and found that Samar Mandal was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his house at Sonaijuri village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Samar Mandal, and detained him. I asked him about the white powder like substance and accordingly, detained Samar Mandal recognized it as "NISHADAL" (approx. 150 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Samar Mandal (37) S/O – Ananda Mandal of village Sonaijuri, PS-Kashipur, Dist-Purulia and arrange for its investigation.
