SI Palash Kumar Barik, Officer-in-Charge of Kotshila Police station, Dist-Purulia, do hereby lodge a suo-motto complaint to the effect that on receipt of a telephonic information at 09:45 hrs regarding obstruction of West Bengal State Highway road (SH-4A) near Khedadi on Purulia- Ranchi road. Myself along with officers and force namely ASI Pardip Kr. Bhattacharjee C/1187Pabitra Mandal, C/223 Jiban Kr. Mohanty, C/109 Ankur Ch. Mudi, JC/1224 Khokon Ch. Hasda, EFR 2419 R/M- Hrikesh Iswari, EFR 258 R/M Utpal Basumata vide Kotshila PS C.C No-3202/17 Dtd-24.10.17 for Khedadih under Kotshila PS, Dist-Purulia, After reaching the spot at about 10:25 hrs, we found that State High way -4A at Khedadih has been blocked by some 100/150 (approx) unknown angry mob over the incident of an accident and death of one Krishnadas @ Sentu Karmakar, S/O-Jashohori Karmakar of Matkuma, PS- Kotshila, Dist- Purulia and creating pandemonium and causing huge Traffic congestion including Ambulances, Passengers busses, trucks and other passengers and goods vehicles making inconvenience to public by which the regular passengers were unlawfully restrained by the agitators from freely moving on the state highway. We requested and subsequently warned several times to remove the obstruction and to regularize the traffic flow as well as to remove the victim and offending vehicle which lies on the highway. But they disobeyed our order as knowing us as police personnel also and having no pay heed our order they took dangerous way to obstruct public way. We were highly outnumbered and we waited for reinforcement for taking further action. The incident of road blockade has been videographed. After several warning from Police and spontaneous interference of local political leaders and dignified persons as well as earnest interference of father of deceased the road blockers retreated back and withdrawn road block at about 14:15 Hrs, ultimately all the unknown persons among the mob who were causing obstruction dispersed from the area. So they committed offence and punishable U/S-341/186/283 IPC and Read with section-18 of West Bengal High Way Act 1964.

After arriving at PS along with officers and force at 15:05 hrs I submitted a suo-motto typed written complaint to to start a case U/S-341/186/283 IPC and Read with section-18 of West Bengal High Way Act 1964 against all 100/150 (approx) unknown persons and others.

Swomitted suo-motto worthen complaint on 24.10.17 at 15:05 hrs at PS & D. 133/17, Started Kotsmile PS case no-133/17, Dtd-24.10.17, UTS-34.1/186/1283 IPC P read with Sec-18 of West Rongul Hydroxy Act-1964.
