Dear Sir,

I do hereby lodge complaint against Sri Madhuna Majhi, S/O-Sri Kanu Majhi of village Tatuara (Majhi Para), P.S-Kotshila Dist-Purulia has committed offence in form of attempt to murder on 24.10.2017 at about 1.30 PM. One my meter reader named Rajesh Ghosal, S/O- Lt.Mrinal Ghosal enter the premises of Sri Madhuna Majhi, S/O-Kanu Majhi of village-Tatuara (Majhi Para), P.S-Kotshila for delivery of bill. Suddenly the accused started slanging my staff with foul languages. After sometimes of slanging the accused brought a wooden stick and started beating him with it saying that he would end the life of my meter reader. In the light of the matter I do hereby lodge a complaint against Sri Madhuna Majhi mentioning the fact that the accused attempted to murder my meter reader and willingly obstructed routine work of WBSEDCL. You are requested to take necessary lawful action against the crime of accused and treat this complaint as FIR.
