After sometimes of slanging the accused brought a wooden stick and started beating him with it saying that he would end the life of my meter reader.In the light of the matter I do hereby lodge a complaint against Sri Madhuna Majhi mentioning the fact that the accused attempted to murder my meter reader and willingly obstructed routine work of WBSEDCL.You are requested to take necessary lawful action against the crime of accused and treat this complaint as FIR.
