Thakurdas Kumar of village- Tatuara(South), P.S-Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 25.10.2017 at about 4.00 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH, entered the premises of Sri Jadav Kumar, S/O-Lt. Thakurdas Kumar of village Tatuara(South), P.S-Kotshila, Dist- Purulia and found Sri Jadav Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.3 KW.
