I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Shibcharan Kumar, S/O- Lt. Sarad Kumar of village- Tatuara(South), P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 25.10.2017 at about 4.20 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH, entered the premises of Sri Shibcharan Kumar, S/O- Lt. Sarad Kumar of village-Tatuara(South), P.S-Kotshila, Dist- Purulia and found Sri Shibcharan Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.3 KW. As Sri Shibcharan Kumar S/O- Lt. Sarad Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato, Gr1 TSH 2. Sri Shibaram Mahato, HG TSH. The inspection team left the premises at 4.30 PM.
