In producing herewith one accd. person namely - Shankhupati Kumar (40 Yrs) S/O Srikanta Kumar of Vill- Basti Kotshila, P.S. – Kotshila Dist – Purulia with seizure of 36 (Thirty Six) sealed bottles of 80 up country spirit “DILSE” containing 600ml each & @ Rs/- 35 of each bottle. 31 (Thirty one) Sealed bottle Of MC Dowelle’s No. 01 Celebration Matured XXX RUM Containing 180 MI each in the rate of 95 of each bottles .

I beg to submit that today (02.10.17) in between 20.25 to 20.45 hrs a raid was conducted in the Snack shop of Kotshila, Shankhupati Kumar (40 Yrs) S/O Srikanta Kumar of Vill- Basti Kotshila, P.S. – Kotshila Dist – Purulia. In course of my SPL raid duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in snack shop. On demand he failed to produce any valid document of concern authority in respect of selling/keeping of liquor of the Snack shop. He was committing such illegal act in presence of police person. As such he was arrested u/s-67 B.E., Act and also seized 36 (Thirty Six) sealed bottles of 80 up country spirit “DILSE” containing 600ml each & @ Rs/- 35 each bottle & of and 31 (Thirty one) Sealed bottle Of MC Dowelle’s No. 1 Celebration Matured XXX RUM Containing 180 MI each & @ Rs/- 95 each bottle **Total Value Rs 4205** which were seized under proper seizure list in presence of witnesses duly signed by the accused person U/S- 67 B.E. Act which enclose herewith out of 36 (Thirty Six) sealed bottles one (600ml) & 31 (Thirty one) Sealed bottle Of MC Dowelle’s No. 01 Celebration Matured XXX RUM Containing 180 MI sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified to the accd. person and issuing arrest memo u/s- 50 Cr.P.C. and a copy of the arrest memo handed over to the accd. Person .

The above noted arrested aced. namely Shankhupati Kumar (40 Yrs) S/O Srikanta Kumar of Vill- Basti Kotshila, P.S. – Kotshila Dist – Purulia, committed offence u/s- 46A © BE Act 1909 for un- authorized possession and selling of country spirit from his Snack shop.

It may note here that during raid (01) C/516 Chandra sekhar Mahato, (02) N.V.F. 1071 Soumen Ghosh accompanied me. Vide Spl C.C No- 30./17 Dtd. 02.10.17

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E. Act. 1909 may kindly be started against Shankhupati Kumar (40 Yrs) S/O Srikanta Kumar of Vill- Basti Kotshila, P.S. – Kotshila Dist – Purulia.
