This is to inform you that I, Shri Prosenjit Biswas, S/o Late Sakti Pada Biswas beside at 2 no. Moha Probhu Para, P.O.+P.S. → Ranashat Dist. → Nadia PIN-741201 and presently beside at "Panday Bhaban", c/o Goutam Chatterjee, Hospital more, P.S.+P.O. → Manbazar, Purulia, is presently posted as Revenue Officer, o/c Bkx HRO, Man-I, P.O. + P.S. → Manbazar, Purulia. I went to a regular fair programme on 15.10.2017. with a staff namely Shri Sadhu sing Sandah, Night Guard (Permanent) at o/c Bkx HRO, Man-I, S/o Sambhunath sing of Vill - Dhanampore P.O. → Jambaid, P.S. → Kendra, Purulia by the order of Bkx HRO, Man-I to Basudi sand Ghat, Mouza-Basudi J.L. No-92, Plot no. - 652/1462 and 460 at around 8:30 a.m.. The lease holder of this Basudi sand Ghat is Satya Bahu, resident of Vill-Basudi, Purulia. There we noticed some truck and tractors were loading sand. I asked one of the persons who were involved in that loading programme to submit the legal challan, that person called someone by phone and refused to submit the challan. Then again I asked others to submit challan, but again they refused and a group of 5 (Five) to 7 (seven) people came at me, made some unlawful activities, restrained me to perform my Govt. duty, then they beaten me by fist and blow as well as my staff. we received physically injury.

In this circumstances it is my earnest request to you to take my complain and lodge an FIR against those persons.
