Sir,

In Producing herewith three(03) arrested accused persons namely 1) Srikanta Chatterjee @Kartick Chatterjee (33 Y) S/O Chittaranjan Chatterjee of Vill- Hijuli, PS- Neturia, Dist-Purulia, 2) Raju Ram(27Y) S/O Ashok Ram of Vill- Amdanga, PS- Neturia, Dist- Purulia & 3) Amrendra Kr.Shaw @ Mithun(25Y) S/O Ramparvesh Shaw of Parbelia New colony Kalimela, PS- Neturia, Dist- Purulia and seized articles i) cash Rs. 30,300 /- (Rs. 2000X13 ,500 X6 ,Rs.100X8, Rs. 50X4, Rs. 20X10, Rs. 10X 10) ii) playing cards -05 sets, iii) One satranji upon which the accused persons were seating on course of playing gambling.

I beg to state that I SI Basudeb Samanta of Neturia PS do hereby lodged complaint to the effect that on 21.10.17 at 21.15 hrs. ASI Deb Chattaraj who was on table duty received an information that one Utpal Chatterjee S/o Lt. Bhupal Chatterjee of Vill- Hijuli, PS-Neturia, Dist-Purulia along with one Apurba Chatterjee S/O Ajit Chatterjee of do had arranged a gambling in a gaming house by making a tent in an open land in the western side of Benapukur of Hijuli village under PS- Neturia. ASI Deb Chattaraj noted the information on PS GDE book vide Neturia PS GDE No- 889 dated- 21.10.17 and informed you about the information received. You directed me along with other officers & force to work out the information.

As per your direction myself along with ASI Purnendu Chandra, ASI Abu Akher, ASI Nivas Mahto C-932 Samiran Dey, C- 269 Lakhindar Tudu, C- 1284 Pratapaditya Majhi, C- 1303 Biswanath Majhi, JC- 702 Pratap Narayan Das, JC- 725 Rahul Singha Mahapatra all of Neturia PS left PS at 21.25 hrs for Hijuli to work out the information vide Neturia PS GDE No- 890 dated- 21.10.17 and CC No- 3253/17 dated- 21.10.17, with Govt. vehicles bearing Regd. No WB56C/8993. At 21.45 hrs. we reached at Hijuli and kept the vehicle there and approached towards the tent in an open land in the western side of Benapukur of Hijuli village on foot and at 21.50 hrs. we reached in front of said tent which was made in an open land in the western side of Benapukur of Hijuli village and tried to surround the tent and found that about 8/10 persons are playing cards on exchange of money in the tent which was made in the western side of Benapukur of Hijuli village with the help of tube light. The organizer Utpal Chatterjee S/o Lt. Bhupal Chatterjee of Vill- Hijuli, PS-Neturia, Dist-Purulia and Apurba Chatterjee S/O Ajit Chatterjee of do were also physically present. We also noticed that the huge amount of money & 5 sets of playing cards is lying on the gambling board.

By this time the assembled persons somehow got the presence of police and some of them including Utpal Chatterjee and Apurba Chatterjee were also managed to escape taking the advantage of comparatively lesser manpower. However we apprehended 03(Three) persons. Being asked they disclosed their

identity as noted above. I seized and labeled the following articles from the board of gambling under proper seizure list.

- i) Cash Total Rs.30300/- (Rs. 2000X13 ,500 X6 ,Rs.100X8, Rs. 50X4, Rs. 20X10, Rs. 10X 10)
- ii) Playing cards -05 sets,
- iii) One satranji upon which the accused persons were seating on course of playing gambling.

The arrested accused persons and others were causing wrongful gain for someone and wrongful loss to others at a same time by way of playing cards sitting in the tent. Utpal Chatterjee and Apurba Chatterjee allowed the arrested persons and others to do the same by sitting in the tent without any Constitutional authenticity. As such the arrested persons and Utpal Chatterjee and Apurba Chatterjee and others are liable for prosecution U/S-3/4 W.B G & P. C. Act, 1957.

Therefore after producing the arrested accused & seized article I pray before your good self, a specific case may kindly be initiated against 1) Srikanta Chatterjee @ Kartick Chatterjee (33 Y) S/O Chittaranjan Chatterjee of Vill- Hijuli, PS-Neturia, Dist-Purulia, 2) Raju Ram(27Y) S/O Ashok Ram of Vill- Amdanga, PS- Neturia, Dist-Purulia & 3) Amrendra Kr.Shaw @ Mithun(25Y) S/O Ramparvesh Shaw of Parbelia New colony Kalimela, PS- Neturia, Dist- Purulia, 4) Utpal Chatterjee S/o Lt. Bhupal Chatterjee of Vill- Hijuli, PS-Neturia, Dist-Purulia & 5) Apurba Chatterjee S/O Ajit Chatterjee of do under proper section of law.
