Dear Sir.

This is to inform you that on 01/09/2017 around 11:00 a.m. when the undersigned along with SSI Arunava Bala and ASSI Upendar Singh from ECL security and 02 (two) nos. of CISF personnel were on surveillance duty of illegal mines near Parbelia village under Neturia Police Station, they found random illegal mining was carrying on all around the Parbelia village under Parbelia colliery of ECL. Suddenly security personnel noticed that one coal loaded tractor (WB-67A-7475) was passing from there. When the security personnel chased the tractor, the driver stopped the vehicle and fled away. Within few minutes, many villagers reached the spot of incident. They besieged ECL & CISF security personnel and started chaos. Taking the advantage of this chaotic situation, some miscreants fled away with the coal loaded tractor.

In view of the above, you are requested to take some serious action against the miscreants who doing illegal mining in above mentioned places and also to lodge an FIR against the tractor number WB-67A-7475 and investigate the whole matter on priority basis.
