Sub-Illegal mining at Pasbelia village (FIR)

Dear Sir,

It is submitted for your kind attention that large scale illegal mining is being conducted at Pasbelia village. Due to rampant illegal mining, the ^{mining operation at} Pasbelia colliery has been asked to be stopped by Director General of Mines Safety (DGMS), Sitampur. Filling/Dozing of such pits is done by ECL with assistance of local police at present. The stoppage of mining operation/activity by ECL will affect the production target and loss of exchequer.
