

The complainant above named most respectfully begs to state:-

- 1 That the complainant is legally married wife of Accused no.d and their marriage was solemented on dated 02.07.2004(Second day of July two thousand and acting at the house of the Complainant situated at Vill Swet Polash & P.O. Chelyama, P.S. Kaghunathpur, under Dat-Purulia according to the Muslim rites, customs and rituals ceremonies prevailing in their community in presence of the parents of both parties, friends and relatives.
- 2 That the marriage in between the parties are negotiated one and the husband accepted to give Rs.11,501/-(Rupees Eleven thousand five hundred and one) as denmeher as stated in "Nacaha nama" and compelling the complainant's father to give Rs.35,000/-(Thirty five thousand) and one Silver chain and one Golden nose pin as downy.
- That both the complainant and the accused no I are husband and wife and are governed by Muslim law and their Marriage tie is still subsisting.
- 4 That after the solemnization of said marriage the complainant went to her matrimonial home at Vill&P.O.-Lipania, P.S.- Para under Dist.-Purulia and where both the complainant and the Accused no 1 started to live as husband and wife.
- That out of their marriage wed lock they were blessed with two sons namely Repayal
 Ansary(Presently aged about 9 years) and Samim Ansary(Presently aged about 3 years) and one
 daughter namely Saimun Khatoon(Presently aged about 6 years)
- 6. That after the expiry of three month of the solemnization of marriage the attitude of the accused no.1 (husband) became quite apathetic towards the complainant and she became an object of negligence and was subjected to physical and mental torture by the accused no.1 (husband) along with all other family members on the demand of money from the complainant's father.

- 8. That the accused no 1 (husband) always suspects about the character of the complainant and often beat the complainant severely blaming that children were not through him and abuse the complainant and her family members using filthy languages.
- 2 That the complainant was deprived of getting daily necessities from the accused no.1 (husband) and the complainant most of the time had to beg food from the neighbour to satisfy her and her children's hunger, even the complainant was not allow to sleep on the bed.
- 10. That once the accused no 1 (husband) kicked the complainant's womb when the complainant was pregnant and due to which the complainant suffered tremendous pain and bleeding instead of treatment the complainant was left to starve without food and water for 3 days.
- 11. That gradually the torture upon the complainant increases and cross its limit, the complainant informed her father about the ill treatment by the accused persons and the father of the complainant tried his level best to settle the dispute between them but not yield any fruitful result.
- 12 That even after the birth of the aforesaid children the nature of the accused persons never changed. The accused no.1 (husband) never bothered to look after and take care of his children and the complainant. The accused no.1 (husband) always returns home late night in drunken state and start quarrelling with the petitioner in silly matters as usual on demand of more money from the complainant's father on the provocation of all other accused persons.
- 13. That the accused persons compelled the complainant to sleep alone in the old dilapidated house in the courtyard along with her children in neglected manner.
- 14. That the complainant being the member of respected family never discloses the cruel torture upon her by the accused persons to anyone except her family member. The complainant hopes that one day the Accused person no.1 will realize his mistakes and will turned to a good man and continues to live with accused person no.1 (husband) in these miserable tortured conditions.

15. That the complainant's poor father requested many times to the accused persons from refraining any sorts of torture upon the complainant but the accused persons did not pay any heed instead they straight forward stated that they didn't want the complainant and the children any more in their house.

That the accused persons never accepted the complainant with proper love and affection dignity rather she was subjected to cruelty and torture. She was equally deprived from her daily requirements as well as conjugal claim where as on the other hand the accused no.1 (husband) is able bodied man and skilled mason earn handful sum of money to maintain his family.

- 17 That the complainant's father intervene into the matter of dispute and tried to settle the dispute in presence of panchyat pradhans of Vill-Swet Polash and Vill-Lipania respectively and elder persons of the villages committee but all in vain.
- 18 That on dated -06/06/2017 in the evening at about 5P M the accused no I (husband) started to beat the complainant severely and drove her along with her children from matrimonial home in bare foot and torn clothes by uttering triple "Talaq"in presence of village people. The complainant informed the incident to the village people and the suggested her to go to her father's house at vill: Swet Polash & P.O.- Chelyama, P.S. Raghunathpur.
- 19 That from this day the complainant along with her children is staying in her poor father's house in miserable condition and could manage to survive with help of her poor father.
- 20. That the complainant informed the matter to the O.C. Para police station (on Dt.-7/6/2017), but they have taken no action against the culprits. Later the complainant filed a petition before S.D.P.O. Raghunathpur (Dt.-27/07/2017) and as well as To the S.P. Purulia (Dt. -27/4-/2017) but unfortunately no fruitful result has been yielded from their end I.e. they also have taken no action against the culprits so far except for condolence. So the complainant has filed this complaint before your honours court today.
