At around 20:45 hrs I received a telephonic information from Kanora Village that a tension was going on there between the people of two different Puja Committees over the issue of immersion. Accordingly I rushed to the spot and arrived at the village at about 21.15 hours and found huge congregation of agitated people who were shouting aloud. The accused persons noted above are known to me, so I wanted to know what for the problem was going on. Accused persons Sl No. 1 to 11 belong to New Durga Puja Committee who took out a procession without permission from us and was restricted by the accused persons SI No. 12 to 22 belong to Old Durga Puja Committee while going through the pandals of them using village path. It may be noted that two Durga Pujas are celebrated at village Kanora by two different groups of people and their dissentment was prevailing since last Durga Puja. The people are so arrogant that when I arranged peace meeting on 14.09.17 at P.S. for peaceful celebration of Durga Puja, these people of village Kanora did not attend the peace meeting, even they did not obtain permission for celebrating Durga Puja from the competent authority. I asked the processionists not to make any procession as they did not obtain permission for celebrating Durga Puja as well as procession but they may immerse the idol of Goddess Durga Maa at the village without making any disturbance. The processionists led by accused persons SI No.1 to 11 did not pay any heed to my request and again started their procession with DJ music system which created a lot of nuisance. At this time some of the processionists suddenly tore off the hanging chains of bulb of Old Durga Puja Committee dangerously without caring a fig that a major accident may happen. Over this issue both the groups of people started assaulting each other, took out their sticks and started pelting stones. I along with my force promptly interfered into the turmoil to pacify them as they were growing more violent. Accordingly I declared the assembly of people as unlawful assembly and ordered them to disperse. They did not pay any heed to my lawful command and showed a determination not to disperse and while I was separating the groups of people, both sides came down heavily on me and my force and they manhandled us and obstructed us in the discharge of public functions. Out of the unruly mob. accused Sadhan Pathak identified himself as an Officer on Special Duty in the rank of Deputy Director of Food and Supply, Govt. of West Bengal and posted at Khadya Bhaban, Kolkata who instigated people openly saying that when two/three persons would be murdered, police would feel the consequences and he misbehaved with us. He forgot that being a Govt. Officer he should not have talked like a layman while he was organizing Puja without any permission from the competent authority and he should not lead unruly people. The accused persons continued joining unlawful assembly even after knowing it that it was commanded to disperse. After long persuasion and effort I dispersed the mob and prevented any further chaos and disturbances and further commission of offence. The accused persons are liable to be prosecuted U/S 147/148/149/151/353/186/427/188/506 IPC and 34A of Police Act 1861. Hence I recorded Puncha PS Case No. 42/17 dated 01.10.2017 U/S 147/148/149/151/353/186/427/188/506 IPC and 34A of Police Act 1861 suomotu and ordered SI Dibakar Kuiri for its investigation.
