I ASI Pradip Dutta presently attached to Purulia (M) P.S. do hereby lodge a written complaint against (i) Sudhir Mahato s/o Lt. Prahllad Mahato, (ii) Sristidhar Mahato s/o Lt. Lilu Mahato, (iii) Sunil Das s/o Lt. Kalipada Das, (iv) Bidhan Mahato s/o Lt. Lalit Mahato, (v) Nitai Mahato s/o Bagdu Mahato, (vi) Subodh Mahato, (vii) Amar Bouri s/o Duda Bouri, (viii) Hiralal Mahato s/o Prahallad Mahato, (ix) Rohit Mahato s/o Jogendra Mahato, and 50 (Fifty) others all of Vill-Golkunda, PS- Purulia (M), Dist- Purulia to the fact that today on (29.10-17) at 10:30 hrs during mobile duty received a source information from duty officer of Purulia (M) P.S. that a buffalo fighting was organized illegally (this refers to Purulia (M) PS GDE No 1053 Dt. 29.10.17) and as per direction of O/C Purulia (M) PS myself along with accompanied force reached at Golkunda village at 11:05 hrs and held an enquiry Golkunda village and surrounding area and learnt that the buffalo fighting was ended and all the organizer as well as spectators left the ground and reveled that the above noted accused persons and 50 others organized a buffalo fighting compaction at the ground of Hirar Ghuta north side of the Shib Mandir of Golkund under Purulia (M) P.S. in the morning at about 08:00 hrs to 10:30 hrs. In the said buffalo fight the accused persons and 50 others inflected injuries upon buffalos which were taken for such fighting and unnecessarily caused pain and sufferings to them. The above noted accused persons also announced 1st prize Rs-3001/-, 2<sup>nd</sup> Prize- Rs- 2001/-, 3<sup>rd</sup> Prize- Rs-1501/-, 4<sup>th</sup> Prize- 1001/-, 5<sup>th</sup> & 6<sup>th</sup> Prize Rs-501/- as also other amount to continue the fighting. A handbill was reportedly circulated by the organizing committee to inform people as to the fighting. It also revealed that some people of other areas of Purulia district took part in the said buffalo fighting.

I therefore request you to take lawful action against accused persons noted above and 50 others.
