

I, Sri Tapas Kr. Ghosh, Inspr. of Police, DEB, Purulia, do here by lodge complaint against Joydeb Gorai s/o Lt. Gopeswar Gorai of Ambareshpally, Garikhana, PS Purulia(T), Dist Purulia and his associates being produced seized articles (i) 96 bags of fortified Atta each bag weighing 49.5 kg and such fortified atta packed in plastic packet contains stamp i.e. it is PDS articles net weight of which 750 gms. Total weight of fortified atta 47.52 Quintal (ii) One 407 vehicle bearing Reg. No. JH 09AG/0876 to the effect that today on 04.10.17 noon received a credible source information to the effect that one Joydeb Gorai s/o Lt. Gopeswar Gorai of Ambareshpally, Garikhana, PS Purulia(T), Dist Purulia owner of Joyguru Rice Mill at Kapur Bagan, procure PDS articles like fortified atta by illegal means from different places and stock it in his rice mill and later sold it in higher prices for causing his wrongful gain and a vehicle bearing Reg. No. JH 09AG/0876 loaded with PDS articles (fortified atta) staying inside the premises of Joyguru Rice Mill at Kapur Bagan under Purulia(T) PS area which will be sold in open market for clandestine business purpose. Accordingly I noted the fact in GD vide Purulia (T) PS GDE No. 151 dtd.04.10.17 at 12:35hrs. District Controller, Food & Supply, Purulia was requested to depute a competent officer from his end to remain present during holding raid search and seizure and arrest but he expressed his inability to provide any such assistance for want of man power at his disposal at the present. Since any delay in working out the said information would cause removal of the PDS commodities I with the consent of my controlling officer left for working out the information in the interest of public service and for implementation of the existing law of the land on this score. Myself along with officer and force (1) WC/461 Tarapada Hazari (2) HG/1427 Benimadhab Char both of DEB, Purulia and (3) SI Soumyadip Mallick along with his force of Purulia(T) PS left for Kapur Bagan under Purulia(T) PS to work out the information. On arrival near Joyguru Rice Mill at Kapur Bagan under Purulia(T)PS. I asked local people viz. (1) Amrit Paswan s/o Durga Paswan of Amdiha, PS Purulia(T) (2) Shyam Barman s/o Lt. Jadunandan Barman of Nilkuthidanga (36) Md. Rijwan Alam s/o Md. Manjur Alam of Garikhana to assist us for holding search the standing vehicle inside the premises of Joyguru Rice Mill bearing Reg. No. JH 09AG/0876. Myself searched for the owner of the said rice Mill and also for the owner and driver of the vehicle but nobody turned up. After observing the all formalities of relating to search, myself searched the vehicle bearing Reg. No. JH09AG/0876 was loaded with PDS articles (fortified atta). Then after proper weighment of the loaded bags which was found inside the vehicle No. JH09AG/0876

with the help of above noted local witnesses, I seized the following articles under proper seizure list in presence of witnesses (i) 96 bags of fortified Atta each bag weighing 49.5 kg and such fortified atta packed in plastic packet contains stamp i.e. it is PDS articles net weight of which 750 gms. Total weight of fortified atta 47.52 Quintal (ii) One 407 vehicle bearing Reg. No. JH 09AG/0876. SL No. (1) was loaded in Sl. No. (2). It is reasonable to believe that the owner of the rice Mill namely Joydeb Gorai s/o Lt. Gopeswar Gorai of Ambareshpally, Garikhana, PS Purulia(T) in connivance with some others made conspiracy to sell the PDS goods in open market at high price depriving the poor and needy card holders of BPL & AAY and the accd. persons made criminal conspiracy to make such type of unlawful activities and there by tried to create and artificial crisis among the poor people of the society after forming an illegal business racket. Hence said Joydeb Gorai s/o Lt. Gopeswar Gorai of Ambareshpally, Garikhana, PS Purulia(T) and his associates committed an offence punishable u/s 7(i)(a)(ii) of E.C.Act 1955 read with sec 120B IPC for violating the provisions as mentioned in Government Notification No.2347-FS/Sectt/Food/4P-09/2012 dtd.08.08.2013 under the West Bengal Public Distribution System (Maintenance & Control) Order, 2013 and thus said Joydeb Gorai i.e. the owner of the Joyguru Rice Mill also violated the provisions as laid down in West Bengal Rice Mills and wholesalers (Control and Levy) Order, 2010 as he has no authority to store and sale any PDS articles(except self manufactured rice) from his rice mill.

Hence I request you to start a case u/s 7(i)(a)(ii) of E.C.Act 1955 read with sec 120B IPC against the accused Joydeb Gorai s/o Lt. Gopeswar Gorai of Ambareshpally, Garikhana, PS Purulia(T) and his associates for violating the provisions as mentioned in Government Notification No.2347-FS/Sectt/Food/4P-09/2012 dtd.08.08.2013 under the West Bengal Public Distribution System (Maintenance & Control) Order, 2013 and for violating the provisions as laid down in West Bengal Rice Mills and wholesalers (Control and Levy) Order, 2010.

A copy of the complaint, xerox copy of the seizure list is sent to District Controller, Food & Supply, Purulia for his information.
