The O/C, Purulia (T) PS,

I, S.I Soumyadeep Mallick of Purulia (T) PS do hereby lodge complaint as suo-motu against (1) Gourab Singh s/o Tarun Singh of Old Police Line, Purulia, (2) Suraj Sharma s/o Lt Sitaram Sharma of Muchipara, Purulia, (3) Nandan Gorai of Zilla School morh, Purulia and 50/60 others to the effect that on 08.10.17 at about 21: 10 hrs received an information that an unruly mob was making chaos with the members of Union Member of Purulia Bus owners' Association at the Bus Union Office situated opposite to Purulia Sadar Hospital, PS- Purulia (T). The subject has been diarized at Purulia (T)PS vide Purulia (T)PS GDE No 370, dated 08.10.17 and as per direction of O/C Purulia (T) PS, myself alongwith ,available officers and force (vide Purulia (T) PS CC No 5046/17) left PS for the Spot. Having reached at the spot it could be learnt that, some unruly mob led by Gourab Singh, forcibly entered into the Union office of Purulia Bus Union situated opposite to Purulia Sadar Hospital under Purulia (T) PS and suddenly attacked some members who were present at that time by demanding to provide the name of the owner as well as mobile number of Victim Bus for medical Treatment of injured person of the accident which was occurred at Aimundi morh under Purulia (M) PS on 08.10.17 evening, in which one person sustained grievous injuries and was admitted at D.M.S Hospital, Purulia. The Union members present, could not supply the name of the owner of the said Bus and requested them to leave the union office. Being furious said unruly mob stafted scuffling with the members as well as abused with filthy languages. They also snatched a gold chain from the neck of one Pradip Banerjee as well as damaged some articles of Bus Union office. After reaching the spot, it was found that, said mob obstructed the NH32 in front of Bus Union Office under leadership of Gourab Singh and 50/60 others and had disrupted vehicular Traffic for a while. They were also shouting slogans against bus owners' association as well as Police. Due to their obstruction, the NH and the main gate of Purulia Sadar Hospital was fully obstructed. They were asked to clear the road, but they did not pay any heed to my word, rather they became more furious and tried to assault police by rampant brick batting. They damaged one Guard-Rail. By their pelted bricks, two police personnel got injury. Finding no alternative, I declared them as unlawful assembly and asked them to disperse from the place. But, they became more violent. Said Gourav Singh threw a big stone aiming to my head with a view to kill me, and shouted that, "PULISH KE MERE FEL", but somehow I could be able to save myself. Then we chased them, when they flee away. We tried to apprehend them, but none could be nabbed.

Therefore, I pray, that a specific case may kindly be started against the above accused persons and for arranging its investigation.
