

In producing herewith the accused persons namely (1) Tofik Ansari (24 yrs) s/o Said Ansari of Mohandih, PS- Pinrajora, Dist- Bokaro, Jharkhand & (2) Jiyaul Ansari (23 yrs) s/o Nosad Ansari, of do, under arrest and seized articles (1) One white coloured plastic bag styled as "GOVERNMENT OF HARYANA" loaded with 22.900 KG Cannabis/Ganja (2) 03 brown coloured envelope containing 100 gm each of loose Cannabis/Ganja which have been collected from said bag as sample & (3) one Honda Shine SP blue coloured motorcycle without registration number and with tampered engine number & Chassis number under proper seizure list sealed and labeled, duly signed by the witnesses and accused persons, I, SI Dipankar Sarkar, O/C Purulia (T) PS, do hereby lodge complaint as suo-motu against the above noted 02 (two) accused persons for committing an offence punishable U/S 20 (b)(i)/29 NDPS Act 1985. Today (26.10.2017) at 12:15 hrs, received a reliable source information that 02 (two) drug peddler namely ((1) Tofik Ansari (24 yrs) s/o Said Ansari of Mohandih, PS-Pinrajora, Dist- Bokaro, Jharkhand & (2) Jiyaul Ansari (23 yrs) s/o Nosad Ansari, of do, riding on a blue coloured Honda Shine motorcycle without number plate are coming from Chas morh side towards Purulia Town by NH 18 on Ranchi road.

The source also informed that they were carrying one plastic bag containing Cannabis/Ganja on the middle of the driver & pillion rider on that motorcycle. I noted the fact in G.D. vide Purulia (T) PS GDE No 1294 dtd 26.10.2017, informed the matter to CI Sadar, Purulia & Dy. SP (HQ), Purulia, and other Superior Officers of Purulia District. As per their direction myself along with my source, SI Bangshi Badan Mondal, ASI Ajoy Mukhopadhyay, C/988, Maheswar Kora, JC/374, Sajal Kundu, JC/1067, Prasanta Malla, HG/1454, Prakash Char, vide C.C. No. 6158/17 dtd 26.10.2017 left for Ranchi road area to work out the information by Govt. vehicle having Reg. No. WB 56C 9388 also carried seal, gala, match box, candle, brown paper, weighing instruments.

Today i.e. 26.10.2017 at 13:05 hrs reached by the side of a "Tentul" tree near Judge Bunglow morh within a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle in a hiding place; we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road extended between Chas morh & Purulia. At about 13:25 hrs one motorcycle rider, identified as Tofik Ansari with pillion rider duly identified by source as Jiyaul Ansari with blue coloured Honda Shine motorcycle without number plate arrived at the pacca road just near the Tentul" tree near Judge Bunglow morh. We watched them for a considerable period, meanwhile, I along with accompanied officers & force disclosing our identities surrounded them & also detained them with the said bag. Being asked, they disclosed their identity as (1) Tofik Ansari (24 yrs) s/o Said Ansari of Mohandih, PS- Pinrajora, Dist- Bokaro, Jharkhand & (2) Jiyaul Ansari (23 yrs) s/o Nosad Ansari, of do. On interrogation, they confessed that, said bag contained Cannabis/Ganja. They also stated that they were carrying the same for selling at Purulia town area. I informed the matter to CI, Sadar, Purulia and Dy. SP (HQ) Purulia. Thereafter, I issued notice to both accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, both detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate, accordingly informed to Sri Dibyajyoti Das, BDO Purulia- I Dev Block (Executive Magistrate) with a request for search and seizure as per provision of section 50 of NDPS Act. Meanwhile, we searched for public witnesses with the help of accompanied officer & force. After a while two public witnesses namely (1) Bholanath Nandi s/o Lt Gobardhan Nandi of Namopara, Purulia, Ward No 19, PS - Purulia (T), Dist - Purulia, (2) Shibu Gorai s/o Lt Manmatha Gorai of Nimtar, Ward No 5, Purulia, PS- Purulia (T), Dist- Purulia, became ready to assist us in conducting search & seizure. Within half an hour CI Sadar, Purulia and BDO Purulia-I Dev Block, arrived at the spot and disclosed their identity and explained the reason for arriving there. After their arrival I started search & seizure process at PO. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Dibyajyoti Das, B.D.O Purulia-I Dev Block and detained persons. At first myself with the help of officers and force searched Tofik Ansari and Jiyaul Ansari and

their belonging at the spot. During search of them found one white coloured plastic bag styled as "GOVERNMENT OF HARYANA" loaded with 22.900 KG Cannabis/Ganja. Thereafter as per direction of BDO Purulia-I Dev Block, I opened some portion of bag and found Cannabis/Ganja in this bag. Accordingly I seized the said bag under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of BDO Purulia-I dev Block. Also packed, sealed and labeled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused persons. I also seized one Honda Shine SP blue coloured motorcycle without registration number and with tampered engine number & Chassis number from the possession of rider namely Tofik Ansari (24 yrs) s/o Said Ansari of Mohandih, PS- Pinrajora, Dist- Bokaro, Jharkhand. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and labeling were done between 14:15 hrs and 16:45 hrs under direct supervision of BDO Purulia-I Dev Block and CI Sadar, Purulia.

So I started Purulia (T) PS Case No 173/17 dated 26.10.2017 U/S 20(b)(i)/29 NDPS Act 1985, as Suo-motu against the accused persons namely (1) Tofik Ansari (24 yrs) s/o Said Ansari of Mohandih, PS-Pinrajora, Dist-Bokaro, Jharkhand & (2) Jiyanul Ansari (23 yrs) s/o Nosad Ansari, of Mohandih, PS-Pinrajora, Dist-Bokaro, Jharkhand and directed SI Soumyadeep Mallick of Purulia (T) PS for its investigation.
