entered the premises of Sri Sudipta Mahato of Amdikhaba ps- Purulia (+) and inspected his premises. During theft of electric was detected. He was using electricity dishonestly by tapping from the nearest LTOH line and enjoying electricity ie v/s. 135(i), 135(i)(b) was detected.

In his premises he was using the following electrical equipment 1. Fan - 02 nos. 2. Bulb 01 3. CFL 02 nos. out of which I have seized the following.

1. P.V.C wire 6mm. 2 core - 15' approx 2. Bulb with holder - 01 no ea Seizure list was prepared at site and the accused person refused to sign on seizure list. The inspection team left the premises at 4:30pm on 12/10/2017. The accused person committed an offence v/s - 135(i)(a), (i)(b) of EA-2003 and amendment Act 2007 you are requested to take cognizance of this complaint and treat it as FIR and action may be taken as per rule.
