Sir,

I. SI Nitish Goswami of Purulia (T) PS do hereby lodge complaint as suo-motu against (1) Ajit Mahato, leader of Adibasi Kurmi Samaj and resident of near Netaji High School, Purulia, (2) Nripen Mahato of Aghorpur, PS- Joypur, Purulia, (3) Nripen Mahato of Bartar, PS- Joypur, Dist- Purulia, (4) Rajesh Mahato of Barogram, PS- Joypur, Dist- Purulia, (5) Pradip Mahato of do (6) Soumyadeep Mahato of Amdiha, Purulia, (7) Swapan Mahato, Secretary, Adibasi Kurmi Samaj, (8) Sudarshan Mahato, President, Adibasi Kurmi Samaj and approx 200 others all of "Adibasi Kurmi Samaj" to the effect that on 17.10.17 at about 13:20 hrs received an information at Purulia (T) PS that an unruly mob led by above persons were taking illegal possession of a house of "All India French Foundation" Chit Fund company at Dulmi, opposite to 40 Quarter under Purulia (T) PS and local people were preventing them to do such illegal act. The subject has been diarized at Purulia (T) PS vide Purulia (T) PS GDE No 830, dated 17.10.17 and as per direction of O/C Purulia (T) PS, myself alongwith, available officers and force at 13:25 hrs (vide Purulia (T) PS CC No 6057/17) left PS for the Spot. Having reached at 13:40 hrs at the spot it was observed that, the unruly mob led by above persons were trying to forcibly enter by breaking the lock of that house of the Chit fund. I asked them to show any document in respect of that house for which they have right to enter the house, but they failed to produce any such document. Then we the police party asked them to leave the place as they have no right for entering in that house. Hearing that, those persons became furious and started shouting against police and obstructed the NH 18 near to that spot under leadership of above persons and 200 others and had disrupted vehicular Traffic for a while. They were asked to clear the road, but they did not pay any heed to my word, rather they became more furious and tried to assault police by rampant brick & stone batting. They damaged one Guard-Rail of WBP. By their pelted bricks, myself and ASI Sukhendu Mondal got injury. Finding no alternative, I declared them as unlawful assembly and asked them to disperse from the place. But, they became more violent. Said Ajit Mahato & Nripen Mahato of Aghorpur threw big stones aiming to my head and head of ASI Sukhendu Mondal with a view to kill us, and shouted that, "PULISH KE MERE FEL", but somehow I could be able to save myself. Then we chased them, when they flee away. We tried to apprehend them, but none could be nabbed. I seized some pieces of stones, bricks and the damaged Gouard-Rail from the PO.

Therefore, I pray, that a specific case may kindly be started against the above accused persons and for arranging its investigation.
