- 1...That your complainant is a legally married wife of the accused no.1 and marriage between the complainant and accused no.1 was solemnized on 20.09.2016 as per Hindu rites and customs prevails in their society at the parental house of the complainant at Village – Jhalda, Station Road, P.O. & P.S. Jhalda, and District – Purulia.
- 2...That the marriage between the parties was result of a negotiation and it was a arranged marriage.
- 3...That at the time of marriage the father of the complainant gave Rs. 1,20,000/- ( Rupees one lack twenty thousand only) in cash, golden ornaments worth 50 Grams (Five Bhuri), furniture's, and other household articles as per demand of the accused persons.
- 4...That after marriage the accused persons took the complainant to their house and the complainant also came to her matrimonial house at Shishu Shiksha Kendra Road, Amdiha, P.O. Purulia, P.S. Purulia (Town), District – Purulia, with a dream to start a happy conjugal life.
- 5...That after few months of marriage the Complainant was subjected to immense Physical and mental torture by Accused Persons for extra demand of dowry worth Rs. 50000/-. She was never accepted with love and dignity by the Accused No.1 and his family members i.e. the accused No.2 to 4.
- 6... That the caustic comments and torture by way of both physical and mental by the Accused persons become unbearable to the petitioner day by day. It was become the practice of the Accused No.1 to beat the Complainant off and on by raising very petty house hold issues.
- 7... That the Complainant bears all such tortures inflicted by the Accused Persons with a hope that all such things will be normalized in the span of time but all in vain .
- 8...That when such states of things are going on in her matrimonial house the Complainant became pregnant and when she inform about the same to her husband and other in laws then the torture upon the complainant become unbearable in her matrimonial house, she was never provided with proper food and clothing, even when the complainant was become serious ill in her matrimonial house in the state of pregnancy the accused persons did not took her before a Doctor or Clinic for her medical treatment. The Accused persons always used to beat the Complainant mercilessly and told her to bring money from her parents if she would want to stay in her matrimonial house. This way the Complainant was subjected to brutal physical and mental torture in her matrimonial house and finally she was driven out from her matrimonial house on 27.03.2016 by the accused persons when she was carrying for only two months.
- 9...That on 27.03.17 the Complainant was forcefully driven out from her matrimonial house by the Accused persons after beating her mercilessly and as there was no other option left to her she came to her parental house at Village – Jhalda, Station road, P.O. & Jhalda, District –Purulia, and since then she is living under the mercy of her father.

That on 16.11.2016 the complainant gave birth to a female child at Singhania Nursing Home, Purulia and since after the birth of her female child the accused persons are started to threatening the Complainant over phone by saying that if she dare to return back to her matrimonial home they would kill the complainant with her minor baby.

11. That your Complainant went to Purulia (Women P.S.) on 25.08.2017 to lodge a written complaint over the above mentioned facts and circumstances but the Officer on duty did not pay any heed to my written complaint and she even not behave with the complainant in proper manner.

12. That your complainant informs the matter stated above to the S.P. Purulia on 30.08.2017 but till date no action has been taken against the accused persons.

13. That having no other option left your complainant filing this Misc.Petition u/s 156 (3) of Cr.P.C. before this LD Court against the accused persons.

14. That the cause of action arose on and from 25.09.16 and still continuing at Sishu Shiksha Kendra Road, Amdiha, P.O.Purulia, P.S. Purulia (Town), District – Purulia.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition filed u/s 156 (3) of Cr.P.C. and treating the same as a F.I.R. be pleased to send it to Purulia (Town) P.S. with a direction to proper investigation and necessary steps against the accused person as alleged in the petition by the Complainant.
