Sir.

I do hereby submit complaint against (1) Jagannath Dhibar s/o Bharat Dhibar of Kargali, PS - Raghunathpur, Dist - Purulia, (2) Monbodh Dhibar s/o Lt Laxman Dhibar of Do, (3) Dulal Gorai s/o Kailash Gorai of Do, (4) Sricharan Gorai s/o Jagan Gorai of Do and (5) Phoni Gorai s/o Kajal Gorai of Do and near about 50/60 other local villagers, PS -Raghunathpur to the effect that I was engaged on L/O duty in c/w immersion of Goddes Durga of Kargali & Chelliyama, vide C.C. No. 3713 dtd 02.10.17. While I alongwith force was returning to PS on completion of duty we found that the road near Pakorimore which runs between Dubra and Chelliyama, had been blocked by above noted persons and near about 50/60 other locals under the leadership of accused Sl. No. 1 as above. They blocked the Pucca road on the issue of non-supply of water by BDO-II in their village. They were raising slogans against BDO & its machinery. I have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 30/35 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Dubra & Chelliyama side were detained there and subjected to enormous suffering for a long time i.e. 14:05 hrs to 15:45 hrs. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles & passerby and thus generated danger & obstruction in public way and also caused obstruction to police in discharging Govt. duty. I had a few photographs of the incident through my mobile camera. After more or less 01 (one) and 1/2 (half) hour discussion, they withdrew the blockade at about 15:45 hrs. On returning to PS, I showed the photographs to my source, CVF & VP and could know the name of above accused only. So, I pray to start specific case against the above accused persons.
