cutting service connection incoming cable and due to this reason he -

P.S. Raghunathpur Dist- Purulia, having Consumer No. 242083238. Meter No. B3892616
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S 135(1)(b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSIEDCL energy meter.

- From the above by-passing system he/she uses the following electrical equipments.
- 1) Bulb (100W) - 01 no.
 - 2) Bulb (200W) - 01 no.
 - 3) TV (100W) - 01 no.
 - 4) Fridge (180W) - 01 no.
 - 5) Electric Fan - 05 no. (60W each)

Out of which I seized the following.
PVC 2 core cable (service) with tapping portion approx - 6 ft.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 3:40 P.M. on 11/10/17. The accused person has committed an offence
U/S 135(1)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

taken as per rule.
