Mendel, Con. id: 242083238 was ~~enjoying electricity amount already i.e. by passing of energy meter by cutting service connection incoming cable and due to this reason he has committed theft of electricity U/s 135 of the electricity (Amendment act- 2007) on 11/10/17 at 3.20 PM L. Subhasis Majhi, S.M., Chetiyama C.C.C. W.B.S.E.D.C.L.~~

Entered the premises of Subal ch. Mendel, Vill. Khantora, P.S. Raghunathpur, Dist- Purulia, having Consumer No. 242083238. Meter No. 133892616 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Bulb (100W) - 01
- 2) Bulb (200W) - 01 no.
- 3) T.V. (100W) - 01 no.
- 4) Freezer (180W) - 01 no.
- 5) Electric fan - 05 no. (60W each)

Out of which I seized the following

P.V.C. 2 core cable (Service) with tapping portion approx - 6 ft.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 3:40 P.M. on 11/10/17. The accused person has committed an offence U/S135(I)/(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
