Sir

In producing herewith accused Sk Kutubuddin @ Gora (36 Yrs.) s/o Sk Ali Hossain of Raidih, PS – Raghunathpur, Dist – Purulia with one improvised country made Pipe gun and one round of live ammunition, I SI Bhudev Ch. Kuiry beg to state that in course of evening mobile duty, special drive, I received a source information at about 19:45 hrs through my cell phone that one person was moving near Simulkundi More on Bankura - Raghunathpur pitch road approx ½ KM away from Bero more towards Raghunathpur Side. His movement was very much suspicious in nature.

Receiving such information, I informed O/C over phone and as per direction of O/C myself along with force i.e. C/1034 Fakir Ch. Mahato, C/201 Rabindranath Nag vide C.C. No. 3861/17 dtd 11.10.17 left Bundla more at about 19:55 hrs with Bolero Vehicle bearing No WB 56G/5945 for Simulkundi More. We reached there and as per identification of my source myself along with force got down from the vehicle at about 20:15 hrs. Seeing us, the above accused attempted to run away but could not succeed. I got hold of his hand and other two accompanied force cordoned him. After detaining him I asked him about his details, purpose of staying there. Firstly he was not revealing the truth but later on repeated question, he revealed his identity as noted above. I informed him that he would be searched by us and offered him to search our person before our search. Finding no other option, he brought out of his back side of waist from inside the back portion of his pant (1) 01 (one) improvised country made Pipe gun loaded with one (01) round 8mm live ammunition having, length as 22 CM approx diagonally from the end point of butt to that of the barrel, length of wooden butt being 7 CM approx, barrel 13 CM approx, having trigger and firing pin. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunition, neither he can gave any satisfactory explanation in respect of carrying such arms ammunition. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition with proper seizure list and the seized arms and ammunition packed, sealed and leveled in presence of police witnesses since none found there available to witness the seizure in between 20:45 hrs and 21:05 hrs. Hence I arrested him at about 21:15 hrs as he has committed an offence which is punishable U/S - 25/27 of Arms Act.

Hence I pray to start specific case against accused Sk Kutubuddin @ Gora (36 Yrs.) s/o Sk Ali Hossain of Raidih, PS – Raghunathpur, Dist – Purulia as per law and arrange its investigation.
