Sir,

In producing herewith arrested accused persons namely (1) Rathu Ganguly(20yrs) S/O-Lebu Ganguly (2) Laxmikanta Paramanik (25yrs) S/O- Lt. Kalipada Paramanik, (3) Laltu Char(20yrs) S/O- Sadhan Char, (4) Mritunjoy @Tapu Mahato (22Yrs) S/O- Balahari Mahato (5) Haren Modak (32yrs) S/O- Ananda Modak all of Kanki Bazar, PS- Santaldih, dist- Purulia along with seizure list and seized items as described below, I beg to state that on 22/10/17 at 14.05 hrs received a credible secret information that one gambling with huge amount of money was going on in the house of Haren Modak S/o- Ananda Modak of kanki Bazar, Ps- santaldih, dist-Purulia. The matter was diaries vide Santaldih Ps GDE no- 708 dtd- 22/10/17. Accordingly as per order of IC Santaldih PS, I, SI Milon Manna along with ASI Sambal Kr. Singh, ASI Dwarak Banerjee, C/ 737 Haradhan Nayak, C/590 Rohit Adhikary, C/ 25 Ujjal Rajak, C/953 Netai Ch. Malik all of santaldih Ps Vide CC No -1729/17 in vehicle no- WB56J/9829 to work out the information. At about 14.25 hrs, we reached near the house of Haren Modak and very slowly and cautiously approached towards the door of the house where the Gambling was reportedly going on. We over heard of talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I told my accompanied staffs to cordon the place and within a moment the place was cordoned by police party. We disclosed our identity and requested them to search raid party accordingly the persons searched ourself and found nothing except wearing apparels and mobile phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (White Plastic Sheet placed on the floor) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another with full knowledge. We searched for the public witnesses but none was available. At about 14.35 hrs. we searched their persons and found playing cards, cash etc.. After that in presence of persons noted above, the board money of Rs 5080/- (Five thousand and Eighty only) with different denomination, 72(Seventy Two) of Playing Cards and one White Plastic Sheet were seized after preparing proper seizure list duly signed by the witnesses and accd. persons also.

As such for committing offence punishable under Sec 3& 4 of WBG&PC Act, all the above noted 05 persons were arrested, issuing arrest memo in between 15.15 hrs to 15.55 hrs.

Therefore, I pray before you to start a case under proper section of law against the above noted accd persons and arrange for its investigation..
