I SI Susanta Kr. Pathak of Adra PS lodge a complaint against accused persons namely accd. 1) Sk. Bablu @ Sabir (30 Yrs.) S/O Sk. Amruddin @ Kabil Sk. of Kethardanga, Ashram Para PS- Bankura (S) Dist-Bankura 2) Sk. Munna @ Babu (28 Yrs.) S/O Sk. Najrul of Kethardanga, Ashram Para PS-Bankura (S) Dist-Bankura 3) Bidyut Dhibar (24 Yrs.) S/O Lt. Sukdeb Dhibar of Jeliapara, Purulia PS- Purulia (T) Dist-Purulia and few unknown others to the effect that on 13.11.2017 at 23.35 hrs, I received a secret source information though my source that a gang of criminals headed by notorious criminal Sk. Bablu @ Sabir, Sk. Munna @ Babu and few others had assembled on the Near Adra Samsan Kali ground and preparing themselves to commit dacoity nearby Upper Beniasole area . This refers to Adra PS GDE No-481 dated 13.11.2017 and I informed O/C Adra PS and as per order of O/C Adra PS, I along with SI Supratik Mondal, ASI Dulal Singh Sardar, JC- 340 Aswini Mondal, JC-342 Kasinath Chakraborty left the PS in Plain Cloth in motor cycle to the anticipated place of assembly. I informed night mobile officer SI Bibekananda Ganguly for proceeding to Near Adra Samsan Kali Mandir along with his force. I along with officers and force reached at the Adra Samsan Kali Mandir at 23:55 hrs and met with other officer and force, briefed them the fact and chalked out the plan. We placed ourselves near around Near Adra Samsan Kali ground and ambush to work out the information and watch the movement of the criminals if any from 00:15 hrs. (14.11.17). On 14.11.17 at 00:35 hrs we noticed that 6/7 persons were getting ready to start for committing dacoity. Their gossiping talk disclosed their plan for committing dacoity nearby house of Upper Beniasole. Gradually I along with officer and force reached at to their place of assembly by crawling and reached to the place about 25 yards away from the place of assembly of the criminals. Surprisingly at about 00:55 hrs, when the criminals could notice our arrival and at once they started threatening us for not to proceed any more before them. We also warned them loudly to surrender but they did not listen to us. At that time all the criminals started to run. we chased after them. After a hot chase we could able to arrest three (03) accused persons from the place of assembly. The arrested criminals disclosed their identity as 1) Sk. Bablu @ Sabir (30 Yrs.) S/O Sk. Amruddin @ Kabil Sk. of Kethardanga, Ashram Para PS- Bankura (S) Dist- Bankura 2) Sk. Munna @ Babu (28 Yrs.) S/O Sk. Najrul of Kethardanga, Ashram Para PS- Bankura (S) Dist- Bankura 3) Bidyut Dhibar (24 Yrs.) S/O Lt. Sukdeb Dhibar of Jeliapara, Purulia PS- Purulia (T) Dist- Purulia. They also cannot recollect the names of other associates At the time of searching the following articles were recovered and seized from the arrested accused persons through proper seizure list in presence of witnesses.

1)One Big Bhojali measuring length 40 cm of iron made was recovered from possession of accused Sk. Bablu @ Sabir 2) One iron made tyre liver (Jac rod) was recovered and seized form the possession of accused Sk. Munna @ Babu 3) One iron made Saval length 3 feet was recovered from possession of accused Bidyut Dhibar.

On interrogation they all stated that they have assembled there for preparing themselves to commit dacoity at nearby house of Upper Beniasole.

I on my arrival back to PS along with other officers and force with the arrested accused persons along with seized articles, lodge the complaint against the above noted accused persons to start a case under proper section of law.
