Prafullya Swarnakar of Traffic Colony, Adra PS- Adra Dist-Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/726 Dipankar Mahato & NVF- 196 Fulchand Paramanik rushed to the spot for raid by Govt, vehicle. At about 18:55 hrs. myself along with force reached at Traffic Colony and hold raid in the Jhupri of Rajen Swarnakar (Traffic Colony, Adra) and found that said Rajen Swarnakar sealing liquor at his own Jhupri and seeing the Police party some person fled away and said Rajen Swarnakar to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.
