

- 3) Nine pieces of plastic glass.


I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accd. namely Sanjay Karmakar @ Mithu (48 Yrs.) S/O Lt. Sagar Karmakar of Vill- Palashkola PS- Adra Dist- Purulia to the effect that on 12.11.17 at about 16:15 hrs. in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one namely Sanjay Karmakar @ Mithu (48 Yrs.) S/O Lt. Sagar Karmakar of Vill- Palashkola PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/411 Pinku Saha & JC/ 342 Kashinath Chakraborty rushed to the spot for raid by Govt. vehicle. At about 16:35 hrs. myself along with force reached at Palashkola, Ranguni More and hold raid in the Tea Stall of Sanjay Karmakar @ Mithu (Near Ranguni More) and found that said Sanjay Karmakar @ Mithu sealing liquor at his own Tea Stall and seeing the Police party some person fled away and said Sanjay Karmakar @ Mithu to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Sanjay Karmakar @ Mithu (48 Yrs.) S/O Lt. Sagar Karmakar of Vill- Palashkola PS- Adra Dist- Purulia and arrange for its investigation.
