that he is using electricity by hooking method to nearest L.T. network with the help of PVC wire which indicates use of electricity dishonestly, and he is using 3 no fans (each 100W), one T.V. set, 6 no bulb with this hooking device. As the theft of electricity was detected during inspection by hooking method, we disconnected the unauthorised electric lines and seized the seizure article in proper seizure list as token basis. The local people refuse to put signature in seizure list. After completion the inspection we left the spot at 12.40 P.M.
