The humble petition On behalf of the above named complainant;

Most respectfully sheweth:

1. That the Complainant is a residence of Dulmi-Mahalla within the Jurisdiction of this Ld.Court and witness No.2 is the son of the complainant and witness No.2 is a college going boy.
2. That accused No.1 is P.S.I.of Arsha P.S. accused No.-2 is a S.A.P. constable being No.C/314, accd.No.3 is the police driver accd. No.4 is the O.C.Arsha P.S.
3. That on 22.5.17. while the witness No.-2 was driving his motor cycle being No.JH-09AE-7726 and proceeding towards Purulia Town on way near Korang village noticed that some Police persons ~~are~~ are detaining the vehicles and are collecting money from the truck drivers for their personal gain and profit with an illmotive at about 10.00 P.M.after blocking the National Highway Road by baricats .Due to baricates the truck drivers and other vehicles were running smoothly one constable was conversing with another person through his cell phone and he was distrubed mind while he was crossing the road,witness No.-2 used horn and alert the person All on a sudden the said constable fell down <sup>in front of</sup> the motor cycle. The Motor cycle skided and the Constable received injuries. Witness No.-2- tried to save the said constable .The accused Nos.1,2,3 were present near the place of occurance and were standing position on the pitch road with Lathi, arms and torch lights . The accused persons suspected that the driver of Motor Cycle dashed the constable ~~for~~ for which the accused persons 1 to assaulted witness No.-2 and witness No.-2 received greivous injuries on his person. The Police officers had an intention to murder witness No.-2 and threw the dead body on the pitch road and they had an intention to screen the evidences. But one

But one co-rider was present there hence they failed to do so.

4. That officer-in-charge Arsha Police Station had every knowledged that accused No.-1 to 3 and injured had gone to N.H.Road for petroling purpose and had every knowledged that the police officers are detaining the vehicles, Checked the paper and collect money from the drivers for their personal gain and profit . The accused No.-1 informed the matter to O.C.Arsha P.S.on the date of occurance through cell phone and as per advise of O.C.Arsha P.S. the Police staffs left the ;place of occurance leaving behind the injured witness No.-2 . The police staffs also assaulted the co-rider by lathi on his back and sustained injury. He was also medically treated.
5. That on 22.5.17. one unkown person shifted the witness No.-2 to Purulia Sadar Hospital for Medical .The complt received one massage at about 10.30 P.M.and attended Purulia Sadar Hospital .Doctor Nayan Mukherjee treated witness No.-2 and as the injuries were greivous in nature he referred the witness No.2 to higher Centre for better treat-ment. The complt admitted witness No.-2 at Bokaro General Hospital . The witness No.-2 naratted the facts to complt and others.
6. That the Police staffs also threatined witness No.-2 and co-rider with mire conseqness used slang languages by saying " বেগী বাড়াবাড়ি করলে গাঁজার কেষে চুঁহাবো " ।  
Due to fear the co-rider is unable to depose before Police and Courts as the financial condition of the co-rider is not sufficient.

- 7. That the complainant made arrange for medical treatment of his son at Bokaro, Ranchi and Bangalore till now the witness No.-2 is under treatment of Bangalore.
  
- 8. That the complainant informed the matter in writing to S.P. Purulia. The Commissioner Human Rights Commission Bhabani Bhawan Kolkata, District and Sessions Judge Purulia and others on 5.6.17. The complainant thought that necessary action will be taken. The complainant went to Arsha P.S. on many occasions, submitted written complaint, the then O.C. Sri Mulla assured that the specific case will be started against the persons after consultation with S.P. /Addl. S.P. / C.I. Purulia . But the then O.C. did not start any case on being transfered another O.C. joined . The complainant went to Arsha P.S. twice. lastly on 29.10.17 the officer-in-charge Mr. Mandal frankly started that no case has started and there is no chance to start a sepecific case because the then O.C. has tampered so the papers . The Complainant thought that he will get relief and as the complainant was badly engaged for Medical treatment of witness No.2 failed to lodge any complain.on- 30.10.17 the complainant lodged further reminder to S.P. Purulia but no action has taken as yet.
