I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Ram Mandal, S/O- Sri lt Jyoty Mandal of villege Kudlung, P.S- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 31.10.2017 at about 02.10 Pm I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Sukhamoy Maji SAE 2. Bagmundi CCC 3. Sri S.K. Pandey Rtd. DSP, Purulia, Region entered the premises of Sri Ram Mandal, S/O- lt. Jyoty Mandal of villege Kudlung, P.S- Bagmundi, Dist- Purulia and found Sri Jyoty Mandal was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Ram Mandal S/O- Sri lt Jyoty Mandal committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE 2. Sri Shankar Ch. Mahato LM. The inspection team left the premises at 02.25 Pm. At 31.10.17
