S/O- Sri Kalyan Prasad Grope of village Sakhedih, P.O- Bagmundi
P.O- Patahesel, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 21/11/2017 at about 1:40 p.m Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Kanulal Dey, Cr-I TSH 2. Santi Kumar Majhi, HGTSH 3. -, entered the premises of Sri Dipak Grope, S/O- Kalyan Prasad Grope of village Sakhedih, P.O- Patahesel, Dist- Purulia and found Sri Dipak Grope was enjoying electricity unauthorisedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Dipak Grope S/O- Sri Kalyan Prasad Grope committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Kanulal Dey, Cr-I TSH 2. Sri Santi Kumar Majhi, HGTSH. The inspection team left the premises at 1:55 p.m..
