I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Bipad Jaran Kumar S/O- Sri Aklu Kumar of village Birgram, P.O- Bagmundi P.O- Birgram, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 21/11/2017 at about 2:20 P.M I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Kamulal Dey, Cr I T S H 2. Santi Kumar Majhi, HGT S H 3. - entered the premises of Sri Bipad Jaran Kumar, S/O- Aklu Kumar of village Birgram, P.O- Birgram, Dist- Purulia and found Sri Bipad Jaran Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0-1 KVA. As Sri Bipad Jaran Kumar S/O- Sri Aklu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Kamulal Dey, Cr I T S H 2. Sri Santi Kumar Majhi, HGT S H The inspection team left the premises at 2:25 P.M.
