Buddheswar Sengupta of villege Sindri, PO-G.B.Sindri, P.O- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 21/11/2017 at about 2:45 P.M. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Kanulal Dey, Cr.I TSH 2. Santi Kumar Majhi, HC TSH 3. -, entered the premises of Sri Srikanta Sengupta, S/O- Lt. Buddheswar Sengupta of villege Sindri, P.O- G.B.Sindri, Dist- Purulia and found Sri Srikanta Sengupta was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Srikanta Sengupta S/O- Sri Lt. Buddheswar Sengupta committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Kanulal Dey, Cr.I TSH 2. Sri Lt. Buddheswar Sengupta The inspection team left the premises at 2:55 P.M.
