Balarampur CCC, WBSEDCL do hereby lodge complaint against Raja Mandi,  
510 St. Lakshu Mandi resides at vill- Paradise, P.O- Namsol, P.S- Balarampur  
Dist- Purulia to the effect that received an information that the aforesaid  
accused person is committing theft of Electricity in his residence by way of  
direct hooking from the LTOH line of WBSEDCL.

Acting upon such information today on 09.11.2017 from 3.30 PM to 4.15 PM  
I, along with Sri Anup Mondal, SAE, Sri Arindam Chatterjee OE and technical  
persons of M/s. Ajay Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises  
of Raja Mandi and held raid.

During raid and inspection it was detected that accused Raja Mandi is  
using electricity dishonestly by making direct hooking from the nearby  
LTOH line of WBSEDCL for running 1 no 100 watt Lamp & 1 no 60 watt Lamp  
having connected load of 0.16 kW. There exists one Service Connection of WBSEDCL  
bearing Consumer ID: 242239138 stands recorded in the name of accused  
which was in disconnected condition due to non payment of energy bill.

I prepared inspection report in presence of the Accused and assessed the load as 0.16 kW. Details have been mentioned in the inspection report which was duly signed by the accused (L.T.I)

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line from our LTOH Line. Accordingly they disconnected the aforesaid hooking line from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused (LTI). A copy of the seizure list was handed over to the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the ~~accused~~ accused.
