In producing here with 2 (two) arrested accused persons namely Chandi Kumar (22 yrs) S/O-Madhusudhan Kumar & Bimal Kumar (24 yrs) S/O-Dinabandhu Kumar both of Vill.- Kairadih, P.S.- Balarampur, Dist. Purulia along with seized one Tube containing 21 (twenty one) ltrs ID Liquor & one Black & Blue colour Hero Honda Splender Plus Motorcycle bearing Reg No.-WB56C/3179 details of seized articles are mentioned in attached seizure list, I beg to submit that today at about 15:35 hrs I received a credible source information that two persons namely Chandi Kumar S/O-Madhusudhan Kumar & Bimal Kumar S/O-Dinabandhu Kumar both of Vill.- Kairadih P.S.- Balarampur, Dist. Purulia is transporting/carrying id liquor for selling at Kendradih village without any valid license. Accordingly, I along with force left for Kendradih village to work out the source information.

After arrival at Kendradih village we found that the above noted two persons are transporting/carrying a Tube containing ID liquor by one Motorcycle as noted above. On demand, they failed to produce any valid documents/ License in respect of transporting/carrying ID Liquor. Accordingly, I seized one Tube containing 21 (twenty one) ltrs ID Liquor & one Black & Blue colour Hero Honda Splender Plus Motorcycle bearing Reg No.-WB56C/3179 (details in seizure list) after preparing proper seizure list & duly signed by the witnesses and accused persons & labelled and also arrested them after preparing proper arrest memo as they committed offence U/S 46A of B.E. Act and supplied copy of Arrest Memo both of them.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A of B.E. Act against the arrested accused persons namely Chandi Kumar S/O-Madhusudhan Kumar & Bimal Kumar S/O-Dinabandhu Kumar both of Vill.- Kairadih, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
